### Chairman,s Speech

Taking into consideration the problemsfaced /grievances of the Safai Karmacharis in the state of Karnataka, the Karnataka State Safai Karmacharis Commission has been established under the Karnataka State Safai Karmacharis Commission Act, 2013 for taking up structural programs for eradicating the disparity in status, facilities and opportunities given to them in the society.

Mr.B.S.Yeddyurappa, Former Chief Minister of Karnataka Government had appointed me as the Chairman of the Karnataka State Safai Karmacharis Commission on date: 01.12.2020 to ban the practice of scavenging and to eradicate the past injustice to Safai Karmachari/Recognized Manual Scavengers by effective enforcement of the Manual Scavengers Act, 2013. When the government entrusted me the post of Chairmanship of the Commission, I was confused because I had sincerely handled the Economic, Information and Broadcasting department, Horticulture, Small Scale Industries and Agriculture portfolios of Karnataka state. At that time, Sri Sri Sri Jagadguru Shivratri Deshikendra Mahaswami, Sattur Mutt, Mysore, said it is good news that I have been appointed as the chairman of this commission. He felt that it is a privilege to serve the most vulnerable people of the society and directed me to strive for their economic, social, educational and political development of them.

A program to create awareness about issues such as cleanliness, medical care, education for their children, using machines for cleaning U.G.D. as against manual cleaning habits and imposing fines for non-use of machines, providing basic facilities etc. is being conducted by the commission under the leadership of the nodal officers through the district commissioners with the coordination of non-governmental organizations and various departments.

During Covid-19 pandemic, all Poura Karmikas have worked daily to protect the health of the society risking their lives and working hard for the eradication of Corona. In order to protect such health care workers, I have personally visited many districts and directed the officials to provide them with protective materials compulsorily and also I have visited their working places and listened to their grievances and solved their problems.

According to the M.S. Act-2013, even though the system of carrying faeces by scavengers has been completely banned, fines and punishments have also been imposed against the contractors/officials who take up cleaning work by engaging other labourers besides urban local body workers without knowing about it, and steps have been taken to create awareness among the public through radio jingles. Signboards also been installed at bus stands, government hospitals, in front of government institutions and other places where public congregates to know fully about the Act. In order to make district and taluk level officials fully aware about the M.S. Act and Rules, 2013, training has also been conducted in 15 districts.

During the visit to many districts of the State, after personally observing that the workers were not wearing the proper equipment and after making inquiries, safety equipment was distributed to many Poura Karmikas. However, they told that they are not wearing because it is difficult to wear. Therefore, to take appropriate action in this regard, the matter has been discussed with the Indian Institute of Science, the equipment from the safety equipment manufacturing companies in the state has been procured, and action is being taken to form a team including skilled doctors, engineers, social workers, legal experts to arrive at the best type of equipment for use. I have visited the workers' colonies in many districts to check the basic facilities provided to them. The concerned authorities are directed to provide houses and other facilities through various schemes of the government.

Since December, 2020 till date 5 cases of manhole death have occurred. In all these cases, the police department and the district administration have been directed to take strict action against the concerned officials and contractors

according to the M.S. Act and Rules, 2013. Also, in relation to manhole scavenging, District Collectors and Deputy Divisional Officers have been directed to impose fines and punishments in many cases and action has been taken by them.

Research has been conducted through the National Law School for the economic, educational, social and legal development of the identified manual scavengers and Poura Karmikas of the State and took action to submit the recommendations in the research report to the government.

In order to identify the manual scavengers in the state, the state government has conducted a survey in 12 districts since 2013 and 5,080 manual scavengers have been identified. The survey of manual scavengers in the remaining 18 districts was started in November, 2021 and will end in February, 2022.

Since the list of cleaning workers working in the private sectors of the State such as companies, hospitals, malls, hotels and other places is not available, it will be impossible to provide facilities for them. Therefore, action has been initiated to conduct a survey of Poura Karmikas through National Law School, Bangalore.

I would like to congratulate the Honorable Sri.Basavaraja Bommayi, for giving the rank of Cabinet Minister to me as the Chairman of the Commission, after the Government observed the functioning of the Commission. I congratulate the Secretary of the Commission and all the staff who have been responsible for taking action on the points mentioned in this book in the last one year and I also congratulate Sri. Kota Srinivas Pujari, Minister of Social Welfare for making all these achievements possible.

### KARNATAKA STATE SAFAI KARMACHARI COMMISSION DUTIES AND RESPONSIBILITIES

KARNATAKA STATE SAFAI KARMACHARI COMMISSION has been constituted vide Notification No: Samvyashai 50 Act 2012, Dated: 04-01-2013. Accordingly, the Commission is officially functioning at No.1/14, South Wing Ground Floor, Silver Jubilee Block, Part of Unity Building Complex, and Mission Road, Bangalore-27 from Date: 01-02-2013.

The Commission is fulfilling the requirements of the Karnataka Act No. 2 of Karnataka State Safai Karmacharis Commission Act, 2013 for All-round Development and Social Security of Safai Karmacharis.

The Commission has been appointed as the competent authority in the State for the effective implementation and the monitoring of the Prohibition of Recruitment of Manual Scavengers and their Rehabilitation Act, 2013 Act and Rules issued by the Central Government.

Safai Karmacharis are individuals employed in urban local bodies, government and private organizations on permanent or contract basis to sweep the streets or to carry out sanitation and cleaning works, Safai Karmacharis are basically, not manual scavengers.

A manual scavenger means an individual engaged in or employed in the unsanitary work of disposing of human excreta from open drains, pits, railway tracks, before it is physically decomposed.

### **Duties & Responsibilities of the Commission:**

The Commission is striving for the effective implementation of the provisions of "THE PROHIBITION OF EMPLOYMENT AS MANUAL SCAVENGERS AND THEIR REHABILITATION ACT AND RULES, 2013" constituted by the central Government. The State Commission is complying with the recommendations issued by the "National Safai Karmacharis Commission, New Delhi" from time to time.

The Commission has the powers of a civil court and functions on the model of a civil court. The Commission has quasi-judicial powers and consists of 1-Chairman, 2-Members (1 female & 1 Male) who are nominated by the Government.

- a. To recommend to the State Government the specific programs to be undertaken under the Time Limit Action Plan in relation to the elimination of disparity in status, facilities and opportunities provided to Safai Karmacharis.
- b. To study and evaluate the programs and implementations related to the social and economic rehabilitation of Safai Karmacharis and to study and evaluate the implementation of such programs and schemes and to make recommendations to the State Government regarding the coordination and implementation of such programs and schemes.
- c. Inquiring into specific grievances means:
  - i. Programs or schemes relating to any category of Safai Karmacharis.
  - ii. The conclusions, guidelines or instructions aimed at alleviating the hardships of the Safai Karmacharis.
  - iii. Measures for social and economic prosperity of Safai Karmacharis.
  - iv. Observing the points related to non-implementation of these aspects.

- d. To consider the problems and grievances faced by the Safai Karmacharis and to submit periodical reports to the State Government on any matter related to the Safai Karmacharis;
- e. Any other matter which the State Government may send to the Commission.

The Commission shall, in the discharge of its functions, be empowered to collect information from the State Government Departments and its agencies, corporations and local bodies in respect of any specific issue.

### **Powers of the Commission:**

The Commission shall have all the powers of a Civil Court while investigating, inquiring any matter under Section 8, under the Civil Procedure Code, 1908 and especially in conducting trials of a suit, namely,

- i. to Summon any person from any part of the State and compel his attendance and examine him on oath;
- ii. to necessitate the investigation and presenting of any documents and witnesses;
- iii. to receive any evidence by way of affidavits;
- iv. to necessitate the submission of any public document or copy thereof by any court or office;
- v. Any other topic as may be prescribed.

### Significant Measures Taken By the Commission to Implement the M.S.Act and Rules-2013 in the Year 2021-22.

- 1. Signboards have been installed at a total of 250 locations including 198 Ward Offices and 52 Hospitals under BBMP limits, in order to create wide publicity and awareness about the messages of sections of M.S Act and to create awareness about the effective implementation of Prohibition of Recruitment of Manual Scavengers and their Rehabilitation Act and Rules-2013 and to spread the information about the facilities available by various Government Departments to Safai Karmacharis/Poura Karmikas/Identified Manual Scavengers.
- 2. A detailed study on social, educational, economic, status of 85 families in the State whose member was died during cleaning of manhole/septic/open drains, is being conducted by the Institute for Social and Economic Change (I.S.E.C.) for the rehabilitation of those families.
- 3. In collaboration with National Law School of India, and I.I.S.C., a meeting is being organized on the use of advanced technology machinery to prevent manual scavenging deaths in the State and steps are being taken to implement uniform safety equipment in the State.
- 4. In relation to elimination of manual cleaning in sewers and septic tanks, a committee has been formed at the State and district level to prepare an action plan and action is being taken for implementation and monitoring.
- 5. A one-day workshop was conducted to collect the opinion of the nominated members of all the district and sub-divisional level awareness committees of the state regarding the ban on the recruitment of manual scavengers and the difficulties in implementing their rehabilitation act and rules-2013 and explaining about the schemes of the central and state governments.
- 6. The 4th State Monitoring Committee meeting was held under the chairmanship of the State Monitoring Committee, Social Welfare Minister, with the members of the heads of various departments to effectively implement the Prohibition of Recruitment of Manual Scavengers and their Rehabilitation Act and Rules-2013.

- 7. It was decided in the meeting presided over by the Hon'ble Minister of Social Welfare to extend the monthly pension, education, recruitment on compassionate grounds, health facilities given in cases of farmers' suicides to the dependents of those who died while cleaning manholes/septic tanks/drainage/open drains.
- 8. It has been planned to print 5,000 books and to distribute in all Metropolitan Corporations, City Councils, Municipalities and Town Panchayats to create awareness about Prohibition of recruitment of manual scavengers and their rehabilitation Act and Rules-2013, and Karnataka State Safai Karmacharis Commission Act, 2012 among the public and in various departmental officers, District Collectors, Chief Operating Officers and Project Directors of the State, Urban Development Cell, Joint/Deputy Director, Department of Social Welfare, Urban Local Body.
- 9. The draft report on the research conducted by the National Law School of India on the social, political, educational and legal status of workers who carry faeces, clean septic pits and of Poura Karmikas in the State was accepted and approved.
- 10. Various wards of Bengaluru city was visited to know about the working conditions of the Poura Karmikas(Covid-19 Warriors) who were working in different wards during the outbreak of Covid-19 epidemic to monitor the safety equipment provided by the government for their use and Bruhat Bengaluru Mahanagara Palike was directed to rectify the grievances.
- 11.A meeting was held with the officials of 8 zones of the Bruhat Bengaluru Mahanagara Palike to discuss on the issues of distribution of safety equipment prescribed by the Health Department and Urban Development Department to the Poura Karmikas who were working in the containment zones in the wake of the spread of the deadly infection of Covid-19, the solution to the problems faced by the Poura Karmikas, the details of the facilities provided by the government, the details of the currently functioning and vacant posts and the technologies being used.
- 12. The 4th State Monitoring Committee meeting was held under the chairmanship of Heads of Social Welfare and Backward Classes Welfare Department, on Date:07.09.2021.

### RECOMMENDATIONS OF THE COMMISSION FOR THE YEAR 2021-22.

- 1. According to section 13 (b) of the Rehabilitation Act, 2013, all the children of these families who are studying should be given special scholarships immediately under various schemes of the government, and necessary caste and inconnecertificate and certificate of unsanitary work(engaged in unsanitary profession) to be distributed on priority by the concerned tehsildars of the district to facilitate their further education. District Collector to issue appropriate order to the tehsildars in this regard.
- 2. Several unions, and workers in the urban local bodies of the State serving since about 10 years and worked even during the COVID period risking their lives, have submitted representations for the permanent employment. Therefore, existing Poura Karmikas shall be recruited on permanent basis against the sanctioned vacant posts of Poura Karmikas in urban local bodies.
- 3. In most of the urban local bodies in the state, 90% of the workers belong to scheduled caste/scheduled tribe and as the roster system is followed during recruitment, the workers who are currently working cannot be made permanent. Since the recruitment of Poura Karmikasis special recruitment the roster system may be removed for one time and the present auto drivers, cleaners and UGD workers may be made permanent.
- 4. 90% women Poura Karmikas are working in the urban local bodies of the state (including the Bruhat Bangaluru Mahanagara Palike) and in the rural areas. There are no toilet facilities, due to which 60% women are prone to permanent diseases and premature death. Therefore, rest rooms must be constructed compulsorily and on urgent basis at mustering points within a period of 3 months.
- 5. As per the report of I.P.D Salappa and recommendations based on the study of National Law School of University, Bangalore, urban local bodies of the state (including Bruhat Bangaluru Mahanagara Palike) in situations where they have previously worked on contract basis in urban areashave employed workers as

per the requirement for solid waste management. But at present, in the situation of direct payment/direct recruitment, workers are surplus in many city and mahanagara palikes. Besides, during the visit, the workers themselves have stated that the work pressure is high on the workers who are currently working as there are no workers in many urban local bodies. Therefore, Poura Karmikas shall be recruited at the rate of one for every 500 people in urban areas and one for every 1000 people in rural areas.

- 6. Permanent, direct paid and contract Poura Karmikas are performing the same work while cleaning daily in urban local institutions but in case of death of permanent Poura Karmikas, their children are being recruited on compassionate basis. In case of death of Poura Karmikas working in BBMP under direct payment basis, the government has issued a circular for 10 lakhs compensation to their family or recruitment to their children under direct payment basis. Accordingly, the government shall issue an order to apply the BBMP model to the direct paid Poura Karmikas working in urban local bodies also.
- 7. As the Poura Karmikas leave for work at 5 am every day, due to lack of child care their children are again dependent on poura karmika profession only. Free education shall be provided to children of Poura Karmikas from 1st standard to higher education in prestigious schools to bring them into the mainstream of the society.
- 8. To extend the Griha Bhagya scheme to Poura Karmikas working on direct payment and contract basis also, which is now being implemented for permanent Poura Karmikas working in urban local bodies(including Bruhat Bangaluru Mahanagara Palike) and working in rural areas.
- 9. To Revise the breakfast allowance from Rs.20/- to Rs.70/- to provide quality nutritious food and drinking water to the Poura Karmikas working in urban local bodies(including Bruhat Bangaluru Mahanagara Palike)of the state.

- 10.To distribute of good quality kits including uniforms and scientific safety equipment to all Poura Karmikas and loaders, cleaners working across the state.
- 11.To appoint one poura karmikas a nominated member in the entire urban local bodies of the State (including Bruhat Bangaluru Mahanagara Palike) as already presented and decided in the budget.
- 12.To provide employment and comprehensive rehabilitation to the family of the scavengers who have suffocated to death while cleaning sewers and septic tanks in the state.

- Poura karmika,s and sanitation workers should be subjected to daily thermal screening and health inspectors should make sure that sanitizers are used compulsorily.
- 2. Transportation facilities to be provided to the work place for Poura Karmikas and other sanitation personnel.
- 3. Provision of appropriate safety dresses to Poura Karmikas and other sanitation personnel assigned to collect waste from quarantine and isolation houses.
- 4. Provision of necessary facilities for personal hygiene after collection of Covid-19 waste. Sanitation personnel should be made aware and instructed on the importance of the work they are performing and on standard operating procedures for precautions and material collection.
- 5. Mandatory provision of PPE kits to avoid infection to Poura Karmikas while handling waste from containment zones and quarantine houses.
- 6. Daily cleaning of vehicles used for waste collection from quarantine/isolation houses, using Hypochloride solution.
- 7. Incentivize Poura Karmikas and other sanitation personnel to take up the COVID-19 vaccine to achieve the target of 100 percent COVID-19 Vaccination (2 doses).
- 8. The Poura Karmikas and other sanitation workers should be examined once in 15 days and necessary measures should be taken to test them for COVID immediately after fever and other symptoms of illness appear.

- 9. If the COVID infection is confirmed during the inspection, such Poura Karmikas shall be subjected to the process of home isolation or admitted to the COVID care Centres.
- 10.All Zone Joint Commissioners, Heads of Urban Local Bodies and Urban Development Cells will monitor the provision of health services and institutional treatment to the COVID infected staff.
- 11.District Commissioners to grant paid leave to Poura Karmikas or other sanitation workers on duty in case of illness.
- 12. Poura Karmikas and other sanitation workers in the Mahanagara Palikes aged above 50 years should be screened immediately if they show symptoms of COVID-19 and sick Poura Karmikas will be given first priority.
- 13.If the family members of Poura Karmikas are suffering from fever, cold etc., they should also be sent to the nearest hospital for necessary check-up.
- 14. Setting up drug spraying stations at all mustering points/wards and mandatory drug spraying to Poura Karmikas while attending work and going home after work.
